Mr. von Lossberg echos Ms. Cares and Mr. Ramos' comments. Mr. von Lossberg did not realize that there were consulting firms specializing in cemeteries.

Ms. Jones believes the timing is great for this project and it is good to take a short and long term look at the cemetery.
