# 3.1 FY 2020 Budget - Mayor John Engen, City of Missoula

Mayor John Engen presented on the fiscal year 2020 Budget. He discussed the lowering of mill levies, the total taxes and assessments converted to mills, the taxable values in the community, value of newly taxable property, the tax increment district value, the revenue per capita for fiscal year 2020, the mill value per capita, an overview of budget resources, the FY 2019 budget performance, and fee resolutions. Mayor Engen also answered questions and concerns about the budget.

# 3.2 Parks, Recreation, Open Space, and Trails Projects in FY20 - Donna Gaukler, Director, Missoula Parks & Recreation

Donna Gaukler presented on Parks, Recreation, Open Space, and Trails Projects in fiscal year 2020.
