#### 3.1 Appointments to the Missoula Planning Board

#### Brad Benshaw

1. Please introduce yourself. Feel free to highlight useful experiences, knowledge or perspectives you would bring to the Planning Board.

Brad has been a caretaker for his daughter for 10 years and now is interested in civic work. He served in the military and is now interested in doing something for the community. He has general contractor license and many certifications to go along with it from Colorado. He has worked in subdivisions, strip malls. He is concerned about the growth in Missoula would like to be more involved.

2. Planning Board advises the City Council and the Board of County Commissioners on land use issues. Planning Board members are asked to weigh in on the growth policy, the zoning ordinance, and subdivision regulations. What about this work appeals to you? Are there particular issues you hope to address?

The traffic patterns are a big problem and the way the city being laid out. Missoula is growing 3.2 % and the salary range needs to be addressed. Environmental issues are an interest also.

3. Rezoning requests can be very contentious. Please describe your approach to reviewing a development proposal that seems to comply with the growth policy and other relevant regulations but is opposed by a large amount of testimony to the board? How do you weigh testimony, geographically and otherwise?

He likes to deal with facts, and has no vested interest in people's business, only the community. Environment issues are his interest. This is a difficult question. There are alot of examples out there and see what works and don't work. 4. A major tenet of the *Our Missoula Growth Policy* is "focus inward." The idea of "focus inward" is to direct new development into already developed areas in the community where services, employment centers, shopping, schools, and infrastructure already exist. Please describe the tradeoffs between infill and Greenfield development.

Infill development on vacant lots depends on what is going in there. He is not favor in high rise buildings over expensive condos. Build what fits into a neighborhood and work on problems we already have. His interest is on the environment, and no poisons poured into the ground.

Contentious, he believes a person has to have an open mind and listen to people who are addressing issues, also work together with ideas.

He doesn't have a lot of knowledge with the Planning Board proceedings. No opinion at this time. Planning Board is doing a good job. Concerned with businesses closing, and Missoula needs to attract more businesses.

#### **Caroline Lauer**

 Please introduce yourself. Feel free to highlight useful experiences, knowledge or perspectives you would bring to the Planning Board. She moved to Missoula for the second time, she worked with Energy Corp and with Chase Jones. She left and went to Climate Smart Missoula and has interest in the Planning Board and issues they grapple with, as that is what she went to school for. 2. Planning Board advises the City Council and the Board of County Commissioners on land use issues. Planning Board members are asked to weigh in on the growth policy, the zoning ordinance, and subdivision regulations. What about this work appeals to you? Are there particular issues you hope to address?

She is interested in affordable housing and climate change and both are tough issues. She would also like to work on zoning and the growth policy with staff.

Open space is huge in Missoula and would like to accommodate people. Infill has state restrictions, height restrictions, and permitting process, and look at impact fees that involve developers. She would like to help preserve agricultural land.

The growth policy is broad and has goals, and the on-going education would help become less contentious.

Us the Land Use policy to model transportation, and encourage bus, bikes and walking. Change the character of neighborhood to make them more vibrant and colorful.

#### Vince Caristo

1. Please introduce yourself. Feel free to highlight useful experiences, knowledge or perspectives you would bring to the Planning Board.

Vince has been working four years as a Transportation Planner for Mountain Line. He has previously lived in several cities in East. He has been on the Planning Board for two years, and it has taken a little while to get used to way things are done. He has a strong feel for environment development.

2. Planning Board advises the City Council and the Board of County Commissioners on land use issues. Planning Board members are asked to weigh in on the growth policy, the zoning ordinance, and subdivision regulations. What about this work appeals to you? Are there particular issues you hope to address?

He likes the work because he is learning how zoning codes work, and attends subcommittee meetings to discuss issues that are regular, like spot zoning, and rezoning requests to see if projects have the right zoning. Another issue is planning costs to rezone, and should be looked at. Others issues include existing residences who don't own their homes and lose them because of rezoning. Adjacent land owners have issues with it also.

How do you weigh testimony, geographically and otherwise?

He considers other people's views about issues at Planning Board meetings, and relays comments back to staff and developers. He understands issues he's hearing. Rezone issues are valid and right but is mindful of his role and is an advisory committee. Likes to be fair.

Infill development is important for sustainability goals. Affordability crisis has changed things and there is a need to find ways to develop affordable. Has been working with transportation issues for people who live far away. Living close to amenities is important. Spoke about Ronald and 4th St. development. Green fill - not much left, need to build houses on Mullan Rd. and there is a plan for that. Need to look at limits where growth should be.

Some unavoidable, policy goals, he hears from people who live next to developments and don't like it. Affordability issues are a problem. Stay on course with policy.

As a transportation designer, proximity of where people live and work makes transportation issues a growing contributor. Need safe options to get around. Learn from other cities and continue with policy goals.

Two issues, length of meetings go a long time. The format of the Planning Board, and it takes a long time to get to know each other. Need more free flowing discussions as there is no discussion between meetings, and it takes a long time to discuss issues. They don't see variances and wonders why. Variances are examples of why zoning codes don't work. Need more updates of where projects are after Planning Board.

### Shane Morrissey

He is an Architect and does a lot of planning and works with Development Services and would like to get more involved with process for better outcomes. Missoula is growing quickly and he would like to see it grow smarter.

Planning Board members are asked to weigh in on the growth policy, the zoning ordinance, and subdivision regulations. What about this work appeals to you? He said the growth policy is good and he is still learning about how the policies and how it works. Some of it doesn't work for certain areas of town, but can make adjustments. There is room for improvements.
