3. Action Items

3.1 Clark Fork Islands Recreation Management Plan

Review public comment on the Clark Fork Islands Recreation Plan. Review of the Recreation Management plan and the incorporated edits.

The group reviewed and discussed all public comment. A synopsis of this review and the decision making process will be prepared and submitted to the Missoula Parks & Recreation Board to assist with plan adoption.

After a thorough review of the submitted public comments the following edits were recommended to be made to the Clark Fork Islands Recreation Management Plan:

a. In section 3 and on the maps, the Garden City Ponds Trail will be designated as dog on-leash. An additional sentence will be added to the plan recommending that future land acquisitions and/or planning efforts in the areas North of the Clark Fork Islands parcels recognize the need for dong on-voice retrain area.

b. Add dog and use restrictions to the descriptive paragraphs of each trail in section 3 of the document.

c. In section 4 of the document reference Chapter 6 of the Conservation Lands Management Plan and the need for a Park Ranger to increase education, outreach and enforcement of park rules and City ordinances.

4.1 Review City Pending Acquisition of MT Dean Stone North

Review the City's pending acquisition and public process related to Mt Dean Stone North.

An introduction to the Mt. Dean Stone project was made by Pelah Hoyt from Five Valleys Land Trust. Grand Carlton described the public process to this point and the Open Space Acquisition Committee's review of the project.

Giles Thelen made the group aware that hew owns property near the top of Mt. Dean Stone and has been working with Five Valleys Land Trust on a way to mitigate potential impacts from increased public reaction adjacent to his property. Giles noted that he may have a potential conflict of interest and may have to excuse himself from future CLAC planning process on the Dean Stone North Parcel.

4.2 Tour Mount Dean Stone

Review current trail construction being conducted by Five Valleys land Trust.

Brian Williams from Mountain Bike Missoula gave the group a tour of the trail construction project he is managing for Five Valleys Land Trust.

This fall CLAC will begin a public planning process for the Dean Stone North Parcel which may also include changes to Phase 3 (unbuilt) trail depicted on the South Hills Spur Recreation Management Plan.
