## AMENDMENT #1 TO PROFESSIONAL SERVICES AGREEMENT

## 3<sup>rd</sup> Street Water Main Replacement Project

THIS PROFESSIONAL SERVICES AGREEMENT AMENDMENT #1 is made and entered into October 7, 2019, by and between the CITY OF MISSOULA, MONTANA, a municipal corporation organized and existing under the laws of the State of Montana, 435 Ryman St., Missoula, Montana 59802, hereinafter referred to as "City," and Territorial Landworks, Inc., 1817 South Ave. West, Suite A, Missoula, Montana 59801 hereinafter referred to as "Consultant."

## **Recitals**

- 1. On December 17, 2018, the above parties entered into an agreement whereby the Consultant agreed to preliminary project assessment, planning, and design; field work and surveying; and Department of Environmental Quality approvals and submittals work on the 3<sup>rd</sup> Street Water Main Replacement Project for which the City agreed to pay the amount of Twenty-Six Thousand, Five Hundred Twenty-Two Dollars (\$26,522.00), herein referred to as "Agreement."
- 2. Since the execution of the Agreement, the parties desire to amend it as set forth in this Professional Services Agreement Amendment to include bidding, construction administration, staking, testing, and project closeout for new water main in 3<sup>rd</sup> Street between Ash Street and South Orange Street at a cost not to exceed Sixty-Two Thousand, Seventy Dollars (\$62,070.00) for the additional work. This brings the total costs for the Agreement to \$88,592.00.
- **3.** Provisions of the original contract dated December 17, 2018, that are not amended herein remain in full force and effect.

## **Amendment**

In consideration of the mutual covenants and agreements herein contained, the receipt and sufficiency whereof being hereby acknowledged, the parties hereto agree to amend the Agreement as follows:

- 1. Paragraph 3, **Scope of Work/Task Deadlines**, is amended to incorporate the following Scope of Services for the 3<sup>rd</sup> Street Water Main Replacement Project: construction administration, inspections, and staking and final project documentation, all as itemized in Consulting Scope of Services & Cost Estimate, attached hereto as Exhibit A1.
- 2. Paragraph 4, **Payment**, is amended in the first sentence to read as follows: "City agrees to pay Consultant an amount not to exceed Eighty-Eight Thousand, Five Hundred Ninety-Two Dollars (\$88,592.00) for services performed pursuant to the Scope of Services."
