In meeting with WGM, we have let them know that Phase 1 of the Brauer project can extend the existing water main currently at 2506 Mount west in Mount then south through the project to dead end at the end of phase 1. WGM has agreed to provide a water easement with phase 1 that would allow the dead end main to be extended south to Strand Ave if phase 2 of the project does not materialize. Phase 2 of the project will be required to complete the connection of the Phase 1 main to the existing Missoula Water main located near the intersection of 27th Ave and Mulberry Lane.
