CRIME VICTIM ADVOCATE PROGRAM

Missoula County founded the Crime Victim Advocate program in 1985 to provide free and confidential services to victims of violent crime. Advocacy forms the backbone of interventions to support victims of relationship and sexual violence, and other crimes. Crime victim advocates have a vital role in the justice system and provide a lifeline to anyone in an abusive relationship. Advocates act as a guide for victims as they navigate multiple systems to find safety and healing from the trauma they have experienced.





JUST RESPONSE

Just Response is a collaborative team of advocates, nurses, law enforcement, prosecutors, protection workers, mental health, and legal services professionals that work together on a variety of projects to create a safe and nurturing community free of violence. When we do this, our community is safer, healthier, and more vibrant.

We value:



- Victim-centered processes
- Offender accountability
- Collaboration, honest communication, and assumption of goodwill with partners
- Self-reflection, adaptability, and accountability

Our goals:

- Increase trust. When victims of crime feel supported and believed, they are more likely to trust the system to seek help from law enforcement, advocacy, mental health, and other services to move toward healing.
- Increase safety. When crime is reported, more offenders are held accountable, and they can get the help they need. We help them learn that healthy relationships are possible and how their actions may be linked to adverse childhood experiences. This strategy can help prevent or lessen future violence in the home.
- Improve collaboration. Professionals in the criminal justice system have differing roles, views, constraints, and experiences, but we work to maintain trust and support one another in challenging work. When the system functions as a team, it works better for everyone.

FY 2019 ACCOMPLISHMENTS

Secured Funds to Close System Gaps

Grant funds supported:

- 80 hours per week of call time for First Step
- YWCA Sexual Assault volunteer advocate stipends, 2 shifts per day
- 24 forensic exams for law enforcement
- Co-location of advocates with law enforcement

- Improved safety for 208

Cross-Disciplinary Training Opportunities

- 8 best practice webinars
- 4 multidisciplinary team in-services
- Full-day conference on creating trauma-informed courts



PREVENTION DIVISION

What brings the most joy to your life? For many of us, it's our relationships with the people we love. But when relationships with our family, friends, or romantic partners are unhealthy or abusive, it can negatively impact our lives, causing trauma, distress, and even physical injury or death.

The Prevention Division envisions a world without violence, and collaborates with Missoula City and County service providers, community-based service providers, educators, and community members to move our community closer to that vision.

Looking back at FY 2019

- Awarded over \$250,000 in multi-year grant funds to support leadership development and prevention education.
- Provided 134 educational lessons to 1,233 middle and high school students in our service area.
- Facilitated 11 meetings of the Missoula Healthy Sexuality

 Network, a group working to promote comprehensive sex education.



SOCIAL MEDIA & COMMUNITY ENGAGEMENT

Make Your Move! is an innovative campaign that engages community members as allies in preventing sexual violence. The campaign is housed at Relationship Violence Services and includes partners from the YWCA Missoula, University of Montana, and the Missoula City-County Health Department.



Engaged over 500 community members through training, tabling, and community events.



Made 375+ posts on social media, resulting in 4,500 comments and shares and 8,900 clicks.

Our sexual harassment prevention training for alcohol-serving establishments was spotlighted by the CDC in a video series on public health heroes! This training helps ensure that Missoula's vibrant nightlife is safe for everyone.

RURAL PROGRAM

Nearly one-third of Missoula County residents live in rural communities. Rural residents may face significant barriers to receiving help after experiencing domestic or sexual violence or stalking. Rural victims are more likely to lack access to jobs, public assistance, social services, transportation, and affordable housing. This makes it that much harder to leave an abusive partner and gain safety for themselves and their children. In 2010 Missoula County partnered with neighboring Mineral County to expand the reach of the rural program.

The Rural Program provides critical, life-saving services to underserved rural communities in Missoula County and Mineral County.

Invested **\$216,000** in **U.S. Department of Justice** funds into

DIRECT SERVICES

Provided 9,430 services to 725 rural clients, including advocacy, emergency shelter, mental health counseling, and legal services.

PREVENTION EDUCATION

Provided 105 lessons for nearly 700 middle and high school youth at schools based in Superior, St. Regis, Alberton, Seeley Lake, Condon, Lolo, and Frenchtown.

TRAINING

Sent three staff to three national conferences and provided trainings for Partnership Health Center, YWCA Missoula, and Parents as Teachers.
