Ms. Ratterman discussed buildings and facilities natural gas and electricity use.

Ms. Ratterman discussed "right sizing" vehicles.

Ms. Merritt asked if there are any decisions being made about the trees at the poplar farm.

Mr. Bickell states the city may plant alfalfa instead of trees in the future at that site but nothing has been decided currently.
