# 3.3 Approve Buy-Sell Agreement to purchase 1205 West Broadway (Bridge Apartments)

Mayor Engen presented this item. There are about 20 residents currently in this property and we are interested in keeping these residents housed. This is not to be property managers, but rather have someone else manage the property and keep these people housed. This to be purchased with Missoula Redevelopment Agency/TIF funds. We want this property to continue to be used in perpetuity.

Jesse Ramos - What is Western Montana Mental Health's explanation for putting the City in this very difficult position?

Mayor Engen - Western Montana Mental Health feels this is not an asset they can continue to keep on their books due to reduction in funding. I will not speak for them, but this is something we can step in and help with.

John Adams offered a presentation regarding the details of this purchase. Please see attached presentation. Ellen Buchanan and Eran Pehan also discussed items in the presentation.

Council posed a number of questions regarding the funds to purchase and bonding, etc., and had a discussion on this item. Dale Bickell explained the City will cover the purchase price and once sold, and the purchase price is determined, then balance will be made up with bonding and hope to have this done within the next few months. Eran Pehan noted there have already been several partners interested in this project and Western MT Mental Health will continue to manage the facility until the building sells.
