## CONTRACT TERMS

1. GRIZZLY CORPORATION shall furnish only the materials and labor in this contract, any changes made from the above, necessitating additional material or labor shall not be included or covered by this proposal, but shall be provided for under a written job change authorization. Any surplus materials remaining upon the completion of the installation shall remain the property of GRIZZLY CORPORATION. When materials covered by this contract are for the replacement of or addition to existing fences, GRIZZLY CORPORATION shall be in no way responsible for the functioning of any part of the existing structure on which changes are not made by GRIZZLY CORPORATION.
2. The Customer, by accepting this offer, warrants that there are no violations of any zoning, or building codes, regulations, laws or ordinances of any public authority.
3. This contract **DOES NOT** include any grading, surveying, nor removal of any existing fence, or plants unless specified in writing. GRIZZLY CORPORATION **IS NOT** responsible for damage to under ground sprinklers that are unmarked or improperly marked. GRIZZLY CORPORATION will repair the damage at an additional charge of time and materials.
4. The amount of this offer does not include the furnishing of any materials or labor necessitated by the occurrence of unforeseen circumstances subsequent to the date of this proposal or to any condition not readily discernible at the date of this proposal, and GRIZZLY CORPORATION shall have the right to cease any installation which has begun and/or cancel this agreement and recover the reasonable value of the materials and labor furnished to the date of cancellation. The reasonable value of such labor and materials to be based on GRIZZLY CORPORATION current retail prices thereof and the labor charges of any subcontractor who is performing any part of the installation.
5. GRIZZLY CORPORATION shall not be liable for any delays in the completion of an installation resulting from or due to labor difficulties, civil regulations, acts of God or any cause beyond the control of GRIZZLY CORPORATION.
6. This proposal, and the attached specifications, sketches and blueprints, if any, shall constitute the entire agreement between the parties, which may not be altered or modified except by written agreement duly executed by both parties.
7. This agreement shall not be binding upon either party if not accepted within thirty (30) days from the date hereof.

## WARRANTY

When this contract includes installation GRIZZLY CORPORATION will, for a period of one year from the date of installation, repair or replace and install any parts found to be defective in materials or workmanship. **DOES NOT INCLUDE WOOD FENCES.**

The parties recognize that an inspection of the premises where the installation is to be made is desirable for the protection of both the customer and GRIZZLY CORPORATION. Therefore where the proposal includes installation, an inspection shall be made before or after the delivery of the materials to be installed, but prior to installation thereof. Commencement of the installation shall constitute approval of this proposal by GRIZZLY CORPORATION. **THE CUSTOMER HEREBY ASSUME FULL RESPONSIBILITY FOR THE LOCATION OF THE LINE UPON WHICH SAID FENCE MATERIALS ARE TO BE INSTALLED,** and Customer agrees to defend, hold harmless and indemnify GRIZZLY CORPORATION from and against all claims, liabilities, and expenses for injury, death or damage to persons, property damage, trespass and all other damage or loss arising out of the installation or location of said fence materials.
