#### **Background and Alternatives Explored:**

The Westside Park Master Plan was adopted by Park Board on September 10, 2019. The MCPS Board of Trustees approved the master plan in November 2019. MCPS and the City executed a Lease Agreement for development of and extending use of Westside Park until August 2044 as a neighborhood park in December 2019. Phase 1 of the master plan implementation was completed in the spring of 2021, and included a preschool age playground, new picnic shelter and portable toilet enclosure.

Phase 2 of the Westside Park Project includes replacing the elementary school age playground, new sports court, new multi-use turf area and associated site work including new trees, turf, irrigation and park pathways.

The design for the park was developed through an extensive public process including the Northside/Westside neighborhood, Missoula County Public Schools, and Lowell Elementary school students, staff, and parents. The implementation of the master plan will be an important improvement to this neighborhood park which serves a low/moderate income neighborhood with a growing population.

The park design utilizes Crime Prevention Through Environmental Design (CPTED) principles to help build community, increase natural surveillance, and reduce undesirable behavior in the park. The new playground is designed to be accessible to children of all abilities and includes unique features that will help foster interactions among children of differing backgrounds and abilities.

The playground equipment and installation will be purchased through cooperative purchasing programs, that ensure the equipment and installation meets city procurement rules regarding fair and competitive pricing.

## Financial Implications:

The total amount of \$863,438.71 is part of an approved CIP for FY22, funding for the project will be paid for from LWCF Grant funds, and private donations.
