3.1 Transportation Options Action Plan

Mr. Wilson also explained the existing policy directives that were incorporated into making the Transportation Option Action Plan. He added more details when he covered how they identified the need for the action plan. The three main components that were focused on in creating the plan are the Transportation Option Programs, Incentive and Requirements, and Districts and Partnerships. The committee made comments about ensuring families with small children can use public transit, provide electric vehicle charging stations and get ideas for when the passenger railway will be available to the public.
