#### 3.1 Memo of Understanding for the Midtown Master Plan

Aaron Wilson Infrastructure and Mobility Planning Manager presenting,

The purpose of this Memorandum of Understanding (MOU) is to facilitate the Missoula Metropolitan Planning Organization (MPO) contribution to the Midtown Master Plan. The MPO has approved \$50,000 in funds committed to the Master Plan and is funded from Federal Planning Grants. Once this MOU is signed the MPO can reimburse the Midtown Master Plan for some of the expenses. The MPO is federally mandated and facilitates collaboration between the City, County, and the Montana Department of Transportation with transportation planning.

The Midtown Master Plan is organized by the Missoula Midtown Association for the area along the Brooks Corridor and the surrounding area. This has been modeled on the Downtown Master Plan and will focus mostly on the commercial area of the Brooks Corridor. Today's request would approve the agreement between the City and Midtown Association for the transportation elements of the master plan and limited to the \$50,000 in the transportation element.

Ms. Jones is on the Midtown Master Plan Committee and wants people to be aware that this master planning creates a base for more housing, access to parks, and good quality of life for citizens. Ms. Sherrill said she is also on the committee and it's important to plan for the growth of our community.

Ms. Vasecka asked if the Midtown Master Plan has had any private donations. Melanie Brock with the Midtown Master plan explained that around thirty businesses have

contributed to this plan. The business have been in support of this plan to see more connectivity. The city received a raised grant to help with rapid transit on Brooks and this grant will come through at the same time as this plan.

Mr. Nugent explained that he has not heard anything negative on this master plan and he is very active in this area.

The older vehicles will be sold at the auction. These vehicles come in over budget due to the change in vehicles. However, there is still money in the overall Capital Improvement Budget.
