Dave,

I could not confirm that the letter was sent so I am glad I reached out. I was just talking with our mapping side and they mentioned one, possibly two LOMRs that should be issued for the City in the next few weeks:

1. 21-08-0781P\_LOMR for Rattlesnake Dam Removal

2. 21-08-0878P\_LOMR for Middle Grant Creek

Here is the Agricultural Structure language that is suggested to replace Section 10.4(4) in the City of Missoula Floodplain Regulations :

Agricultural Structures - The following additional requirements and exceptions from the requirements of Section 7.4 apply to agricultural Structures not intended to be insurable, used solely for agricultural purposes, having low flood damage potential, used exclusively in connection with the production, harvesting, storage, drying, or raising of agricultural commodities, including raising of livestock and animal confinement facilities, and not intended for human habitation:

1. Such Structures may be exempted by the Floodplain Administrator from the Lowest Floor Elevation requirements established in Section 7.4.1 provided the Lowest Floor of the Structure is elevated to at least the Base Flood Elevation or adequately dry floodproofed in conformance with the requirements of Section 7.2.16; and

2. Such Structures shall comply with the requirements of Section 6.11.

The community could wait and update both the AG structure language and Appendix A once the LOMRs are issued. Those are the only two changes that we identified with the community regulations.
