# 3.3 Professional Services Agreement with Utilis, Inc. for an Underground Water Leaks Satellite Imagery Analysis

Jerry Ellis Water Operations Superintendent presenting,

This agreement would be for fly-over imagery of the water system to look for leaks. Water leaks are one of the City of Missoula's biggest problems and they are very hard to find. The water enterprise fund has money left in the budget for this fiscal year so the City decided to have this satellite Imagery done. The City of Spokane has done this in the past and said that it worked really well. They went from a thirteen percent leakage down to a ten percent leakage rate. The Satellite uses radar to look for treated water in conjunction with GIS data.

Mr. Hess said he appreciated the data-driven approach. Ms. Becerra asked how long it would take to collect the data. Mr. Eric Trerotola with Utilis, Inc. said it would take around three to four weeks. Mr. Nugent asked what the City plans to do with the leakage on private lines. Mr. McInnis said he does fear that the results will show so many leaks they will be hard to prioritize. Mr. Nugent also asked if this data will affect their ability to get the insurance. Mr. McInnis said that is a good concern and he is not sure at the moment how to address that. He said he believes the insurance does have a preexisting condition exclusion.
