3.1 Memorandum Of Understanding Adoption – Trinity Navigation Center

Stacie Anderson, Sandra Vasecka and Gwen Jones joined the meeting at 2:42 p.m.

Rikki Henderson, Housing Program Manager, with the Community Planning Development and Innovation department (CPDI) gave information regarding the Memorandum of Understanding (MOU) between the City of Missoula and the All Nations Health Center. She outlined partnering with the All Nations Health Center to design a services and staffing model for the Trinity Navigation Center. She introduced Sky McGinty, Executive Director of the All Nations Health Center. Ms. McGinty gave organizational background including populous the center serves, services provided, community impact and vision for the Trinity Navigation Center. Please refer to the attached video for detailed information.

The committee requested clarification regarding the Native specific agencies that serve the Missoula population and the function of these organizations. A committee member requested clarification on the relation between the Partnership Health MOU and All Nations Health Center. Ms. Henderson indicated the partnerships are separate entities,

occupying different space in the building. The lease for the All Nations Center is held by the city.

Public Comment: Carissa Trujillo with Homeword, recognized the All Nations Health Center and how this partnership would round out services provide the Navigation center.

3.2 Contract for Poverello Center Veterans Transitional Housing

Heidi West, committee chair, introduced Tracy Pondorf, ARPA Grants Administrator, with the Community Planning Development and Innovation department. Ms. Pondorf presented information on the contract request awarding the Poverello Center \$843,000 of City ARPA funds in support of property acquisition for veterans transitional housing. She provided an overview of the Housing Montana Heroes Program and outlined plans for the funding.

A committee member questioned the impact on the Veterans if the motion was not passed. Ms. Pondorf reiterated the funding is an eligible, allowable ARPA expensed. The committee discussed COVID impact on the numbers the Poverello Center could serve and how the veterans housing would ease the impact. Jill Bonney, Executive Director of the Poverello Center, elaborated on this topic. Committee member, Jordan Hess, wanted to note for the record that he is on the Board of Directors for the Poverello center, there was no conflict of interest. A committee member questioned the long-term fiscal responsibility of the housing, including maintenance. Ms. Bonney conveyed that fiscal property will be incorporated into the Poverello Center's operating budget, and part of that funding was provided by the Veteran's Administration.
