3.3 Professional Services Agreement Amendment No. 1 with IMEG for the East Front Water Main Replacement Project

Andy Schultz, City Engineer for Utilities presenting,

This is an amendment to the design and construction administration for the East Front Street Water Main Replacement Project. Once working on the project, the City found that they could eliminate about 1200 more feet of old water main by adding around 800 feet of new water main. This amendment will cover the survey and design and longer construction time. The water main already has to bore under rattlesnake creek, so it makes sense to replace as much as possible at one time. The total cost of the amendment is \$36,892.50 and will be paid from water enterprise funds.

3.5 Professional Services Agreement with Woith Engineering for the 5th Street Water Main Replacement Project

Triston Firth Utility Engineer presenting,

This professional service agreement is with Woith Engineering to design and oversee the construction of a water main project on South 5th Street West. Woith Engineering was selected as part of a Request for proposals process earlier last year. This project covers three and a half blocks from Garfield Street to Russell Street. This project will replace around 1,750 feet of water main from the 1970s and was prompted by the City Streets' plan to replace the asphalt on this street section. The total water main cost is \$109,404.00 and will be paid out of the Water Enterprise Fund.

3.6 Agreement to Release Ditch Easement with the Great Northern Medical Center Association

Jeremy Keene, Public Works Director, presenting,

In December 2021, the City of Missoula purchased the Flynn Lowney irrigation ditch. The city let the property owner know what the intentions were with each property. In some cases, the city retained the easements for future use, and in some cases, the easements were released. The land owner asked us to release the ditch easement in this case. It is in an area where the city does not need to retain the ditch. The city requested some compensation of \$10,022.30 for this release to recoup some of the cost of the ditch. The amount was based on land values and then discounted to \$1.25 a square foot. The creates additional area and adds value to the property for the land owner.

Mr. Nugent asked if it was possible to get this easement back in the future. Mr. Keene said this was looked at very closely, and the purposes the city could use in the future are unnecessary.
