RE: Seeking comment for the proposed amendments Title 5 Missoula City

Business Licenses and Regulations Ordinance regarding cannabis

businesses.

The Montana State Department of Revenue began accepting applications on January 1, 2022 from medical cannabis businesses licensed prior to November 3, 2020 to become recreational cannabis businesses. Recreational licenses from new businesses will be accepted by the State beginning July 1, 2023. To reflect the creation of this new business license type, staff are drafting an ordinance to amend Title 5 Business Licenses and Regulations. The proposed regulatory revisions will be applied to both medical cannabis and recreational (adult-use) cannabis.

New standards are being introduced for cultivation businesses. These business types will be required to meet the new standards in order to obtain a cannabis business license.

The proposed amendments to Title 5 include:

- Reformatting Chapter 5.04 for readability,
- Incorporating additional provisions within Chapter 5.04 Definitions related to cannabis uses and regulation,
- Incorporating additional provisions within 5.08 Licensing Provisions Generally related to cannabis licensing and regulation, and
- Creating Chapter 5.120 Cannabis to incorporate requirements for carbon filters at cultivation and cannabis manufacturing facilities.

The attached document includes a general description, provides amendment language, and an explanation for each suggested amendment. Amendments are shown as strike-through and underline. For reference, the current Business Licenses and Regulations Ordinance (Title 5) can be viewed online at:

Following the concern expressed in November 2021 by both Planning Board and City Council over the high energy usage associated with cannabis cultivation, City Council directed staff to amend Title 5 to incorporate revisions regarding energy consumption for cannabis cultivators. The energy-conservation regulations initially proposed by staff were and are constrained by the Montana Code Annotated Section 50-60-102(6) which requires local energy conservation standards that exceed the energy conservation standards contained in the state building code to be voluntary and incentive-based. For this reason, staff are not moving forward with energy regulations at this time. Staff will, however, be returning to City Council to describe the constraints within state law and provide possible routes forward through incentive-based energy codes. City Council will not be voting on any energy regulations at this time. Instead, they will hear different regulatory options and provide guidance to staff. A memo will be issued prior to the public hearing.

Agency and interested citizen comments are needed to refine the proposed amendments. Comments received by Friday, June 17, 2022 will be included in an informational packet to City Council prior to their public hearing. Comments will continue to be taken by City Council after this time until the public hearing is closed.

After agency and public input, the Land Use and Planning Committee will hold a Pre-Public Hearing Special Presentation on Wednesday, July 13, 2022 beginning at (time TBD), and the City Council will hold a public hearing on Monday, July 25, 2022 beginning at 6:00 p.m. City Council's Final Consideration on the proposed ordinance will be held on Monday, August 8, 2022 beginning at 6:00pm.
