

**RESOLUTION NUMBER**

**A resolution of the Missoula City Council increasing fire inspection, plan checking, pyrotechnic display and police and special event fees increasing fees by 7% effective January 1, 2023 as shown in Exhibits E & F.**

**WHEREAS**, 7-1-4123(7) MCA authorizes local governments to charge reasonable fees for the provision of services; and

**WHEREAS**, the City of Missoula has conducted an official fee study in 2010 to establish the costs of providing certain services; and

**WHEREAS**, the City Council duly advertised and conducted a public hearing relating to these proposed fees; and

**WHEREAS**, in accordance with the City Charter, Article 1, Section 6, a public hearing was duly advertised on July 24, 31, and August 7, 2022, and held by the City Council on August 22, 2022 through the adoption of the final budget in order to give the public an opportunity to be heard.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council hereby amends and adopts the fees as shown in Exhibit F with an effective date of January 1, 2023.
