3.1 Wastewater Primary Effluent Pump Upgrade

Currently, the city has three effluent pumps, two of which are 75 HP pumps that have been in use for 18 years. The third one is a smaller pump that would be upgraded to a 75 HP pump. The upgrade will allow for more capacity to pump and provide a backup. In the 2009 facility plan, it was recommended to do this upgrade.
