The Montana Code Annotated Title 15 governs the laws around Montana Property Taxes, and the Missoula City Charter reaffirms that the city shall not increase property taxes above limits authorized by the State, unless approved by a ballot vote. The city also collects fees for certain permits, including business licenses, plan checks, fire inspection, industrial wastewater processing, and others. Montana Code Annotated Title 7 Chapter 6 and Article 1 Provision 6 of the Missoula City Charter outline fee laws.

Between 2022-23, the city will also receive \$14.2 million from the American Rescue Plan Act, which is governed by Federal House Bill 1319.

The opportunity with property taxes is they tax wealthier owners at a relative rate, and they avoid the creation of a sales tax. However, fixed and low-income homeowners with one residence have felt the tax burden disproportionately during the recent housing crisis, as the only way for them to benefit from rising values is to sell their primary residence. Meanwhile, someone wealthy enough to own a second/summer/investment property can sell at a profit without sacrificing their home. In this way, property taxes can become effectively regressive.

The opportunity with ARPA is arguable, as that money hasn't necessarily offset the uptick in budget needs associated with rapidly increasing population and COVID-19 fallout. The obvious limitation to ARPA funding is that it is temporary.

- 2. Collective ownership: Wealth and property are concentrating across the country, and that concentration stifles small business and economic diversity. Expanding collective ownership of residential and commercial properties can ensure a better financial landscape across the city.
- 3. Environmental health: Missoulians are facing the need to improve insulation and retrofit for air conditioning on a massive scale. There is an opportunity to harness skilled trades and emerging technologies to adapt to the changing climate.

- 4. Nonviolent policing: City police are tasked with too many responsibilities beyond the scope of their job, including triage of mental health crises that do not require weapons or force. The Missoula Mobile Support Team is just the first important step to better unarmed municipal mental health services.
- 5. Social fabric: Digital socializing and political polarization are cutting people off from their neighbors and making it harder for long-term residents to feel connected (and new residents to feel welcome). We can reinvigorate community networks through small-scale events and improved neighborhood council meetings.
