I want to serve as Mayor of Missoula to not just continue the great quality of life Missoulians expect, but to aspire for the future of Missoula as an example of all that a Montana city can be. I want Missoula to be a lovable, livable place that is forward-looking. Missoula needs a Mayor who intentionally directs the city toward a sustainable, inclusive, prosperous future with the tools available as a municipal executive.

3.7 What is your understanding of the Mayor's general role in leading Missoula? The Mayor works closely with City Council, City staff, and constituents to serve community needs. She sets the tone for the city, looking forward to guide the city into the future in line with the values of the community. The Mayor must maintain good relationships with City Council, even when they disagree, to chart the course of Missoula and keep the town functioning.

3.8 What is your understanding of the Mayor's legal responsibilities and obligations in leading Missoula? The Mayor of Missoula's role is to work as the executive, enforce the ordinances and resolutions passed by the City Council, staff and lead the departments of the City of Missoula, day-to-day administration of City services, appoint of staff members, submit an annual budget, and preside over City Council meetings. The key responsibility of the Mayor is the annual budget. The Mayor also reaches out to other governments as the proxy for Missoulians. The Mayor of Missoula also takes part in strategic plans for Missoula.

3.9 What is your understanding of the Mayor's cultural and social leadership role in leading Missoula? The Mayor of Missoula is an active participant in the community, which means he or she engages with constituents from all wards and all neighborhoods to be familiar with the variety of lives lived by Missoulians. She represents Missoulians by acting as an examplary of a citizen, attending social functions, talking with constituents, and immersing himself or herself in the community. She is a figurehead that Missoulians ought to be able to look to as a model citizen, even if they disagree with her politics.

3.10 Describe your leadership philosophy and style to lead during a crisis.

My leadership philosohpy is to identify people's strengths to help people help themselves. A Mayor is a jack-of-all-trades, but master of none, but the city has people who are masters that the Mayor should know and should know how to get the most out of their skills. What this means in times of crisis is identifying the people who are best suited to respond to that specific crisis and giving them the support they need to mount a successful response. Leadership often means getting out of the way to let folks do their jobs, but taking accountability for the results.

3.11 Explain the taxation structure for local government, listing all main revenue sources and the law that applies to each, and discuss opportunities and limitations on those revenue sources.

The primary revenue source for a local government like Missoula is property taxes, which are based on market values of land/property within the city limits and a generally consistent, often increasing. Property taxes can be increased with mill levies. Other sources include transfers from state and federal government, which can often come with strings attached from Helena and D.C. and maybe subject to fluctuations from year to year. Some funds also come from charges from municipally owned utilities like Missoula City of Water.

3.12 What are the most pressing issues Missoula will face in the next few years? List a total of five, explain why they are of importance, and rank them in order of importance (1 being most important). How would you address these issues? 1. Affordable housing. There are not enough homes being built at all income levels, partly due to clumsy zoning, partly due to the time it takes to build homes. I would evaluate zoning, ADUs, and other 1% solutions that could add up tremendously. 2. Climate adaptability. Fires will threaten Missoula and extreme seasons are coming, Missoula needs adaptive infrastructure and to use the money from the Inflation Reduction Act. 3. Urban Sprawl/Annexation. Growth is an opportunity for Missoula, but has costs for services and livability. 4. Public Schools/Property Taxes. 5. Public Health 3.13 Who are the leaders of the executive branch of City of Missoula government that report to the Mayor and how would you approach working with these leaders and their staff?

The leaders that report to the Mayor are the directors of the municipal departments. I would approach working with them by not siloing the staff and their departments but generating interconnectivity towards a common vision of a livable, lovable Missoula with frequent meetings. I would make sure respect is present in every interaction and that all actions by the staff are in line with the goals of the strategic plan.
