Heidi West, committee chair, called the meeting to order at 12:30 p.m.

3. COMMITTEE BUSINESS

3.1 Montana Department of Commerce contract, NeighborWorks Montana subrecipient agreement

Tracy Pohndorf, ARPA Grants Administrator, Community Planning, Development and Innovation outlined two contracts for approval. The first was an \$850,000 award from Montana Department of Commerce to create a new resident owned community in the city. The second contract is a sub-award to NeighborWorks Montana to carry out the project. Ms. Pohndorf explained that the funding originated from the CARES act and is identified as a Community Development Block Grant Coronavirus (CDBG-CV). She described the stipulations on the funding at both the federal and state levels. She then explained NeighborWorks' role in the establishment of a resident owned community (ROC) in Missoula. Ms. Pohndorf announced both contracts are ready. She introduced Kaia Peterson, Executive Director of NeighborWorks Montana. Ms. Peterson further expanded on the grant submission for the ROC program. She conferred that manufactured home communities are at greater risk for redevelopment resulting in citizen displacement. Ms. Peterson also discussed the social makeup of those that live in these communities. She identified Old Hellgate Village as the target property. Ms. Pohndorf outlined the motion brought before the committee.

Councilperson Anderson made the recommended motion. Various committee members gave comment in support of the motion highlighting the vulnerable situation these communities are in, another committee member did not support the motion. For further information please see the attached video.

3.2 Operation Shelter Interlocal Agreement with Missoula County

Montana James, Deputy Director of Community Planning, Development and Innovation introduced an agreement between the City of Missoula and Missoula County and gave background on the city and county collaboration to develop a plan of response to address the increase in those experiencing houselessness due to the pandemic. The agreement would honor the funding and operating relationship between Missoula County and the City of Missoula in the operation of the shelter. The Interlocal agreement outlines the administration, financial rolls, effective dates, amendment procedures and high-level overview of the projects. Ms. James highlighted the motion.

The committee and Ms. James discussed the timeline on the Interlocal agreement. Councilperson Sherrill made the recommended motion. The committee and Ms. James discussed staffing and infrastructure of the project. Committee members also discussed local business owners' frustrations with the shelter and plans in place to help alleviate those frustrations and protect the business interests. A committee member reiterated what the vote is relating to.
