3.1 Edward Byrne Justice Assistance Grant (JAG 2022) MOU

Scott Hoffman is asking to set a public hearing for the 2022 J Edward Byrne Justice Assistant Grant in the amount of \$62,922.00. Part of the money goes to the county. That amount is \$13,751.00 to be used for the property clerk position. The portion that the Police Department will receive is \$49,171.00. They will be using it for is Secure Warrant, which is an online warrant system. The second item they will use the funds for is the virtual academy, which they use for online training. The third thing they anticipate purchasing is night vision sights for rifles.
