3.4 Professional Service Agreement with Morrison-Maierle for the Kelly Island Lift Station Rehabilitation

This professional services agreement is for reconstructing the Kelly Island lift station. The Kelly Island lift station is out of Mullan Road and serves a large area, including the Mullan BUILD area. The pump station requires improvement to function in this growing area fully. An additional wet well may be needed, or the current one may need to be replaced

with a larger one. The total is \$65,548.00, and the funding will be from the wastewater enterprise fund through and State Revolving Fund (SRF) loan.
