**Background and Alternatives Explored:** On June 6, 2022 a member of the Affordable Housing Resident Oversight Committee resigned, creating an opening for a community member seat. Prior efforts to appoint someone resulted on no-shows at the time of interviews from all applicants. A vacancy was then posted and closed on September 20, 2022 and two applications were received: Kristina King and Menodora Le Master, both satisfying the requirements of the position.

On June 8, 2022 a member of the Affordable Housing Resident Oversight Committee resigned, creating an opening for a member from the housing or real estate field. A vacancy was posted once with no applications received, and was reopened on September 12, closed on September 26 and three applications were received: Julie Pavlish, Kara Hogan and Colin Lane. All three satisfy the requirements of the position.

Staff from the Affordable Housing Resident Oversight Committee are eager to fill these vacancies, as the board has not been fully staffed since June and they have their annual strategic planning meeting on October 20, 2022.
