3.2 Union Place Apartments Low Income Housing Tax Credits (LIHTC) Application

Emily Harris-Shears, Housing Policy Specialist with Community Planning, Development and Innovation outlined the tax credit application and the intended use of the funds. If awarded, the funds would be used to execute needed rehabilitation to the Union Place apartment complex and preserve the dedicated use of income restricted units. She introduced Kassy Buss, of Bjornson Jones Mungus PLLC and Jack Jensen of the development team. Ms. Harris-Shears shared that the public hearing allowed for community perspective and input regarding the proposal as well as satisfied the state's public hearing requirement for tax credits. Ms. Buss provided background on the Union Place Apartments, outlined the need for rehabilitation, detailed the tax credit application and highlighted the number of rent restricted units. Jack Jensen presented information on the scope of renovation, community amenities, unit amenities, and major renovation items. He provided the target income for these units.

The committee and Mr. Jensen discussed the relocation plans for the current tenants during the renovation period and funding set aside for the temporary displacement. He proceeded to breakdown the total number of units and unit type. He elaborated on the 4% tax credit and, if awarded, the anticipated timeframe for receipt of funds and the project completion timeline. For further information please watch the meeting video.
