My beliefs have created a career on these ideas, which has led me through a 20+ year journey of creating affordable housing, supportive housing, attainable housing, senior housing, and non-profit projects. I deeply appreciate the City's significant efforts to address the housing crisis, and believe that the City's leadership will have meaningful impact. I have expertise and interest in ensuring these efforts are maximized in their impact.

What skills and perspective will you bring to or draw on as a member of the Affordable Housing Resident Oversight Committee ? Please include any experiences (lived and/or professional) or familiarity you have with affordable housing, zoning, funding, housing policy, or other relevant skills: With over twenty years' experience in creating housing and housing solutions for our community, I am acutely aware of the magnitude of the housing crisis. I bring a detailed understanding of the intersection of policy and real-world factors in implementing housing solutions, from both a private developer perspective and a non-profit developer perspective. I have created housing in other communities in Montana and can offer other communities' perspectives. I have also worked with many local non-profits, including YWCA Missoula, MHA, Homeword, and the Strategic Alliance, and can understand the complex and collaborative relationships necessary to maximize the impact of the City's initiatives.

**Describe your vision of a successful Affordable Housing Resident Oversight Committee:** A successful Affordable Housing Resident Oversight Committee will bring expertise and energy to build bridges between the City, residents, and the development community. The City's aggressive approach to addressing the housing crisis means that it is extremely important to balance collaboration with action.

Why, in your opinion, are people in our community (Black, Indigenous, People of Color, those with lower incomes, young people, elderly people, etc.) being disproportionately affected by the affordable housing crisis in Missoula?: Missoula is a special place. I choose to live in Missoula because it is a great place to live, with a tremendous amount of community amenities, social infrastructure, and access to the beautiful outdoors. Many other people agree with me, which creates a tight demand on our limited resources. Marginalized people within our community are the first to experience this lack of resources, and it is our job to resolve these inequities.

For me, one of the biggest indicators is a community's commitment to those who are the least empowered. My childhood in Great Falls, education in Bozeman, and work experience in Helena have taught me what to look for. I appreciate that Missoula is a city where making a difference is not just possible, but welcomed.
