Background and Alternatives Explored: In 2013, prior to the Supreme Court decision on same sex marriage, Council adopted a resolution creating a domestic partnership registry. Now that same sex partners can legally be married, the registry has evolved to a way for Montana residents (this program is available statewide) to declare their partnership and obtain a certificate they present to their employer to receive domestic partnership benefits.

The current process:

1. Couple takes a form to a notary and signs it.
2. They send it to the City Clerk's office.
3. The City Clerk's office adds them to a database and produce a certificate that is signed by the City Clerk, indicating they have been added to the registry and mail the certificate back to them.
4. The couple presents the certificate to the employer.

The City Clerk's office would like to evolve this program from a registry to a form that is available on the City website. Couples will access the affidavit on the website, they fill it out and present it

to their employer for benefits and eliminate the need for the City Clerk's office to process a certificate. This will save time, effort and money for citizens and the City Clerk's office.
