Gwen Jones-I agree that contracts are not normally denied. The whole time I have been associated with City Council, I remember only one time this coming up.

Heidi West-I am wondering how this compares with this County's procedures on procurement. I am wondering about other thresholds below the \$80,000 and possibility of a change?

Eric Hallstrom-That would then go through their procurement policy some of which is set by state law.

Sandra Vasecka-I am wondering what checks and balances are in place if we are not approving items such as this.

Eric-All indications show that the administration is only executing the directions of the council so appropriate processes would be followed in a transparent way. People can still bring items of importance to Council.

Gwen-These items would also be in the approved budget, so that is a check and balance already in place.

Mirtha Becerra-Since this is not for services rendered but rather purchases, who actually does the approving? Is it the Mayor? Is there a list of these?

Eric-I believe that is between the Mayor and the Department Directors.

Leigh Griffing-The department directors have the ability to approve invoices for goods. This is for contracts and I believe this relies on the Mayor.

Jim Nugent-The mayor as chief executive is the one executing contracts, but the mayor signs after reviewing from the attorney's office, so he is the one who executes any and all contracts.

Dale Bickell-The list of contracts the Mayor has signed is available and on that list on the agenda, which all data can always be requested.

Stacy Anderson- It seems that these contracts are things we have already discussed at length.

Eric-We are looking at speeding up the process to be able to take advantage of product availability etc.

Gwen-In speaking with other electeds in other cities, it seems we do a lot of touching of items that others don't.

Eric-Billings uses the most comparable policy to what we are proposing. Billings and Great Falls refer back to state law on contracting thresholds. Bozeman is similar.

Amber Cheryl-These expenses are approved in the budget and this seems to be a good way of streamlining the process.
