3.1 An Ordinance Amending Missoula Municipal Code Chapter 12.44 entitled "Cemeteries"

Katie Emery presenting,

The first change to the Cemetery Ordinances is to the "Location Section." The change would allow for other uses, such as a Pet Ossuary. The grounds regulations section had items D-H removed because these are items that should be in a manual, not in Ordinances. They will be moved to the Cemetery Manual. The section entitled meetings were changed to allow the Board more flexibility in scheduling meeting times. The Board is interested in meeting quarterly rather than monthly. A meeting attendance rule was also added to this section. Article III, entitled Cemetery Superintendent, was also removed because these duties are listed in the job description and should not be in Ordinance form.

entitled "Cemetery Superintendent", Section 12.44.340 entitled "Duties" in its entirety because the duties listed are addressed in the job description.
