3.3 Caras Park River Access Design Contract Amendment

Nathan McCleod discussed the project. The City of Missoula received a grant for construction of the Caras Park River Access. This ties in nicely with the improvements made last year. It will provide an ADA access to the water's edge of the river. People with mobility issues can get down to the water. It also improves/increases the river viewing area. The construction is funded by the grant, but the planning is outside the grant. This is to cover the planning phase of this project.

Linda McCarthy with the Downtown Association said they are committed to this project and bringing dollars to the table. They are in partnership with the City on this grant.

Gwen Jones - This has been huge on the implementation of this Parks' Plan.

Sandra Vasecka - I am concerned about the other funding mechanism that is not the grant. What would the future of the project look like if this were to be voted down.

Nathan - I am not sure. Without a design, we cannot build the project. I am really hoping this is not voted down today. Being on City property we want to make sure we can control the design, so it is safe, etc. If design is turned over to someone else, this could be problematic.

Linda - The other option would be to turn down the grant.

Amber Sherrill - Thank you to the Downtown Foundation and Downtown Partnership. This is huge! It is pretty astounding the number of people floating through there. It shows how much our community goes toward the River now that it is clean. There is a good place to go in and a good place to go out.

Linda - I think there were 80 floaters an hour using the river at the last survey.

Gwen - I would imagine with the pandemic, those numbers actually went up and will continue to go up.

Mirtha Becerra - I would be happy to make the motion. I think the Downtown Association is a catalyst for items like this and when we partner with them, is a win-win for everyone. I feel this project will enhance the vitality of our downtown.

Mike Nugent - I would echo those sentiments. I think this river access will be a great addition to downtown.

Gwen - This is an amazing grant opportunity and if we have to help leverage the use of this grant, I am happy to do this.
