Resolution no. _____

A resolution relating to certain right-of-way infrastructure improvements project 20-062 Worden Ave/Turner St – N 5th St W to Scott St, of the City's Right-of-Way Improvements Assessment Program; approving the final ordering in of improvements

Be it resolved by the City Council (the "Council") of the City of Missoula, Montana (the "City"), as follows:

Section 1. Authorization. The City is authorized pursuant to Section 7-14-4109, Section 7-14-4122, Section 7-15-4125, M.C.A., as amended, and City of Missoula Municipal Code Title 12, Chapter 12.10, to order, regulate and provide for the construction or reconstruction of certain right-of-way infrastructure improvements in front of any lot or parcel of land and may order alley approaches constructed or replaced adjacent to any lot or parcel of land within the City. Pursuant to said Section 7-14-4109 and Title 7, Chapter 12, Parts 41 and 42, M.C.A., as amended, the City is authorized to issue its Right-of-Way Improvements Assessment bonds (the "Bond") to finance all or a portion of the costs of such local improvements.

Section 2. The City has implemented an annual program to cause the construction or reconstruction of needed or unsafe right-of-way infrastructure improvements through various projects (the "Right-of-Way Improvement Assessment Program").

Section 3. Ordering of Improvements. By Resolution No. 8656 approved on January 23, 2023 (the "Order"), this Council ordered certain right-of-way infrastructure improvements of the nature and for the properties described on Exhibit A thereto ("Project 2020-062, Worden Ave/Turner St").

Section 4. Notices to Property Owners. As provided in the Orders and in accordance with Section 7-14-4109, M.C.A., written notice was given to the owners or agents of owners of lots or parcels of land against which the costs of the proposed Improvements were to be assessed and of their option to cause the Improvements benefiting their property to be constructed.

Section 5. Approval or Modification of Original Order. The ordering in of the Improvements as described in Exhibit A to the Order is hereby confirmed. Exhibit A to the Order with any revised cost estimates shall be attached hereto and by reference incorporated herein.
