

From January 11 to January 23, a total of 28 non-fatal and 8 fatal overdoses, likely due to opioids, have occurred in 13 different counties (including Missoula) affecting individuals aged 24 to 60 years old

## The what and why of drug checking tools

Barriers to access?



Drug checking tools (such as fentanyl test strips) help identify the presence of contaminants/other drugs.

These are proven behavioral tools which can reduce the probability of an overdose or overdose death.

#### Fentanyl Test Strip (FTS) Research


Of 81 (87%) participants who returned for follow-up, the majority (77%) used at least one FTS, and of those, a majority found them to be useful and straightforward to use.

Positive FTS results led some participants to alter their drug use behaviors, including discarding their drug supply, using with someone else, and keeping naloxone nearby. Participants also reported giving FTS to friends who they felt were at high risk for fentanyl exposure.

Why is it important for our community to have access to drug checking tools?

Narcan/naloxone only works after someone has overdosed, whereas fentanyl test strips may preempt an overdose from occurring





## Funding from opioid lawsuit settlement

Drug checking tools are an inexpensive solution to helping prevent overdoses

Missoula is eligible for approximately \$223,000 from the Johnson & Johnson opioid lawsuit settlement in the first year and approximately \$150,000 each year for the next 18 years

as low as 45 cents per drug checking tool
