3. COMMITTEE BUSINESS

3.1 Affordable Housing Trust Fund Reserve Balance Funding Recommendation for Bonnie's Place Resident Owned Community

Emily Harris-Shears, the Housing Policy Specialist in the Department of Community Planning, Development and Innovation presented on the recommendation from the Affordable Housing Resident Oversight Committee (AHROC) to award NeighborWorks Montana funding to acquire and convert a manufactured home community (Bonnie's Place) to a Resident Owned Community. She reviewed the Affordable Housing Trust Fund (AHTF) structure as well as the purpose of the reserve funds; she also touched upon the governing values and policies. She highlighted NeighborWorks Montana's request and reasoning behind the application. She described how the request met the use of the reserve balance funds guidelines and goals. Ms. Harris-Shears recapped the AHROC's discussion and recommendations regarding the application and the financial implications of awarding the funds.

The committee, Ms. Harris-Shears, and Kaia Peterson of NeighborWorks Montana discussed the long-term goals of the acquisition, the resident ownership opportunities, and the benefits of the conversion to a Resident Owned Community in relation to the preservation of affordable housing. They also discussed the financial impacts of depleting the reserve funds and the details of the AHROC meeting including the committee and public discussion.

3.2 Contract for Montana Rail Link (MRL) Triangle Remediation and Delisting

Tyler Walls, Brownfields Program Specialist in the Department of Community Planning, Development and Innovation provided a MRLTriangle Remediation project overview, the site location, and site history. He outlined the Request for Qualifications (RFQ) process, the remediation aspects, the next steps, and the estimated completion schedule. He proceeded to describe the financial implications, grant requirements and the selection of the WGM Group. He reiterated the project alignment with the city's growth and housing policies/goals. - The potential impact on the Bitterroot trail system in the area.
- The extent and focus of the cleanup as well as the delisting of the property.
- The abatement timeline and grant requirements.
- The difference between the total funding request and the contract amount and the intended use of those funds.
- The potential impact on existing buildings and amenities.
- Brownfields roll in the process.
