Annual Allocation Plan

- AHTF administers two competitive award cycles per year
 - The Unified Application Round-Winter
 - Affordable Housing Trust Fund Application Round-Summer; when applicable
- •The **reserve balance** is set by the Affordable Housing Resident Oversight Committee
 - A maximum of 20 percent of the available balance can be reserved annually
- The reserve balance is held for urgent and emergent acquisitions
 - The Affordable Housing Resident Oversight Committee will oversee the reserve balance and vote on the use of reserve balance funds

Reserve Balance

In December of 2021, the Affordable Housing Resident Oversight Committee allocated **\$261,550** to the reserve balance to remain available for emergent and urgent projects throughout the year

Reserve Balance Request: \$80,000

Consumer Housing Services Project: The Centralized Housing Solutions Fund (CHSF) is a flexible financial assistance fund intended to prevent and end experiences of houselessness for Missoulians.


United Way of Missoula County – Centralized Housing Solutions Fund

Impact of Previous Investment

Received a \$26,250 AHTF award in November 2021

- •138 households prevented or ended an experience of houselessness
- •Common Uses:
 - Deposits
 - Applications
 - Rent/arrears
 - Travel costs to return to home community where housing is available with family/friends
- •\$400/household average


Primary Race of Individuals Accessing MCES, 2021

Discussion Summary

- •Strong application that highlighted the need and impact of flexible funding to prevent and end experiences of being unhoused
- Meeting an urgent and unmet community need
- Timing/raised whether this application is a better fit for the competitive round
- Systemic realities and need for more housing was raised
 - CHSF allows housing system to do both- respond to immediate needs people have while systemic issues including low housing stock are addressed
- Curiosity about sustainability and future funding needs

Financial Implications

- •The reserve balance was set at \$261,550 by the AHROC in fall of 2022.
- •The balance currently reflects the initial allocation, as no requests have been advanced to the AHROC before the United Way of Missoula County's request.
- •If the \$80,000 request is approved and funded, \$181,550 will remain for applications to fund emergent and urgent requests.

Recommended Motion

Set a public hearing for Monday, November 28, 2022, to consider the funding recommendation made by the Affordable Housing Resident Oversight Committee to fund United Way of Missoula County to operate the Centralized Housing Solutions Fund.
