#### What is your interest in serving on this board, commission, or committee?\*

Missoula has been our home for over 25 years. It took nearly 40 years for me to move my family back to my native state. I love this place and want to do what I can to help preserve its historical heritage as we move ever so quickly into the 21st Century. Missoula is well known for its Downtown, which, in my view, is largely due to the presence of its many historic buildings. Therefore, I want to be part of the body that reviews and guides projects insofar as they relate to our historical legacy.

I had my office as a practicing Landscape Architect in Downtown Missoula from 1999 until 2016, sharing a space with Steve Adler, architect and member of the Historic Preservation Commission. During that tenure I learned a great deal about the HPC and its value as an advisory board to the City Council. As can be seen from my CV I am also a Historian, although I've not marketed my services as such. I do, however, highlight that expertise on any proposal that might involve historical antecedents to the particular project. That is why I have checked three of the four positions on the Commission.

### Do you have any special knowledge, interest, or experience that would qualify you for a position on this board, commission, or committee?\*

As a Landscape Architect and Historian I am currently the volunteer Historic American Landscape Survey (HALS) Liaison for Montana. This program is administered by the National Park Service in cooperation with the American Society of Landscape Architects. In that role I'm in the process of preparing HALS documentation on the Going-to-the-Sun Road in Glacier National Park, a well-known feature that has been designated a National Historic Landmark, and is on the National Register of Historic Places. In addition, I plan to prepare HALS documentation of the eleven (11) surviving American Elms that were planted on the grounds of the Veteran's Hospital at Fort Harrison, Helena, in about 1944. The hospital grounds are already part of the Fort Harrison VA Hospital Historic District.

As detailed further in my CV I operated a tour company, Lewis & Clark Heritage Tours, serving as a guide to key Corps of Discovery sites during the Lewis & Clark Bicentennial from 1999 through 2006. With assistance and guidance from other cartographers and historians I prepared hand-out maps for both the Bitterroot and Lolo Trail Sections traversed by the Corps.

Historical Activities, Public Service

**Experience:** 

Lewis & Clark Heritage Tours, Missoula: Director/owner of tour company founded in 1998 to lead tours to various key sites related to the Lewis & Clark Corps of Discovery in western Montana during 1805 and 1806. As a historian I had long been intrigued with the expedition and wanted to share my knowledge and interest with others who would be traveling to our area to re-trace the Expedition's trail during the Bicentennial celebration. With assistance and guidance from other cartographers and historians I prepared hand-out maps for both the Bitterroot and Lolo Trail Sections traversed by the Corps. Each map indicated the approximate location of the camp sites used by the expedition during September 1805 and June/July 1806. Between 1999 and 2006 I led several hikes, private tours and worked mostly as a step-on guide for Elderhostel Tours coming through our area.

Travelers' Rest State Park, Lolo. In 2002 I was retained by the Traveler's Rest Preservation & Heritage Association (TRPHA) as both a landscape architect and Lewis & Clark historian to prepare a Conceptual Master Plan for this new state park. It was during this period that the physical evidence of the Corps' occupation of this site was excavated in the form of mercury residue from the medicinal pills ingested by members of the expedition in 1805 and 1806. As result, this is the only archaeologically verified campsite of the Lewis and Clark Expedition in the nation. The master plan served as guidance to future development and interpretation of the State Park.

<u>Historic American Landscape Survey (HALS); Montana Liaison.</u> The American Society of Landscape Architects and the National Park Service have an agreement that provides for ASLA members to be the volunteer liaisons for HALS activities in their respective states. As the Montana liaison I produced an informational flyer in 2007 that highlighted the importance of surveying and fully documenting the Butte Mining Landscape, the Eastern Montana Small Towns and Homesteads, and the Lewis and Clark Portage around Great Falls. I continue to monitor any development activities around the state that may threaten significant historic landscapes.

<u>Pend d'Orielle Bay Trail, Design Charrette, Bonner County, ID.</u> Under the auspices of the Idaho-Montana Chapter, ASLA, I was the team leader for the "Interpretation, Education and History" element for the POBT Design Charrette that has held in Sandpoint-Kootenai-Ponderay, ID in 2009. I led our group of  $\pm 10$  local interested individuals through a design process that became an integral part of the overall conceptual plan for this three-mile long trail along the north shore of Lake Pend d'Orielle. Landscape Architecture Day, Going-to-the-Sun Road, Glacier National Park, MT. I was the Idaho-Montana Chapter coordinator for this 2010 event, which honored the historical contribution by Thomas Vint, NPS Landscape Architect, who, in 1924, convinced NPS Director Stephen Mather to build the trans-park road along the alignment we enjoy today. The August event brought in the public together with a surviving son of Vint's, and other

family members who had not previously understood or appreciated the contribution that Vint had made in Glacier National Park, and ultimately, the design of all subsequent roads on federal lands. An interpretive display at "The Loop" along the scenic Road commemorates Vint's contribution to its design.

### Background:

Being raised in Yellowstone Park and trained as a Landscape Architect, I come naturally to my strong interest in environmental affairs. As volunteer conservation activist in the late 1960s, I served as Conservation Chairman for the S. F. Bay Chapter of the Sierra Club and coordinated a number of significant conservation battles in the Bay Area during that period (1967-72), including the Briones power line controversy, the successful efforts to save Apperson Ridge from a massive quarry which led to California's first environmental impact report (1968), and various actions involving potential loss of open space.

My interest in children's environmental education comes from the knowledge that well-educated children who care for and understand the environment are the only hope for our future. This interest manifested itself through my involvement as a parent and professional landscape architect in creation of Montana's first Schoolyard Habitat certified by the National Wildlife Federation - the "Outdoor Discovery Core" at Lewis and Clark School in Missoula (1997-2001) (see below).
