I am a Montana licensed architect with post-graduate degree in historic preservation. The company I work for is located in a downtown building with street front presence. I have been a member of the Historic Preservation Commission since early 2017 and have, with the new HPO, worked to refocus the HPC on the future of Missoula's historic resources, sustainability of existing resources, diverse ways we can celebrate other historic aspects of our community (Legacy Business), and change the inner workings of the Committee including a relook at the demolition ordinance, review of HPC bylaws and recently, with the support of many others, the /AR Overlay that looks to incentivize historically buildings.
