Bid Award Recommendation

Dear Logan and Ross,

As a summary, the bids for the above project were due electronically only via the QuestCDN bidding site on July 16, 2019 at 1:00pm (local time) and then opened online via the QuestCDN bid site and read aloud by the Missoula City Clerk, Marty Rehbein. At the time of bid opening, <u>four (4) electronic bids</u> were received and all bids were reviewed and considered responsive by the City Clerk at that time. Territorial-Landworks then conducted an additional and more thorough review of the electronic bids to confirm the responsiveness of the bidders.

A review of the Bid Form completeness was conducted. All contractors acknowledged the one (1) addenda, listed 3 projects of similar complexity (except for FirstMark Construction who only listed 2), listed ACI technician information, completed the Bid Form, and provided unit prices and totals for all items and schedules.

After completing the Bid Tabulation in Microsoft Excel as double-check based on the unit prices provided by the Contractors' submitted bids, there were no apparent math errors and the bids submitted as shown on the QuestCDN website, appear correct.

We have reviewed the submitted bids for completeness and accuracy and based on the unit prices, we have determined that <u>Western Excavating</u> is the apparent lowest responsive bidder with a total bid of <u>\$275,268.00</u>. The engineer's estimate for this project was \$297,930.00.

Therefore, based on the thorough review of all bid conditions and unit price bid sheet with no math corrections required, Territorial-Landworks, Inc. recommends <u>Western Excavating</u> for the Missoula Water – Alder Street & Cooper Street Water Service Swap Project.
