On behalf of The Nature Conservancy I'd like to urge your support for Five Valleys Land Trust's efforts with the Mount Dean Stone project. This next step is a critical one toward the overall effort and I hope the Committee supports this request.

The Mount Dean Stone Corridor builds on decades of successful conservation work surrounding the Missoula Valley. The Corridor enhances the conservation value of previous Open Space Bond investments in the South Hills Spur and the Barmeyer and South Hills conservation easements by expanding public access, habitat protections, and the ecosystem services these open space lands provide. The Corridor is forward thinking, as well, because it sets the stage for additional trail connections and habitat protection on Mount Dean Stone South lands to the south and east. ## RE: City of Missoula Acquisition of Open Space on Mount Dean Stone

Dear Open Space Advisory Committee:

On behalf of MTB Missoula's more than three hundred members in Missoula's city planning area, please consider our unqualified support of City of Missoula ownership and management of the open space acquisition proposed here. This "Mount Dean Stone Corridor" will provide a unique and irreplicable asset for Missoula, and will create new and diverse opportunities for individuals and communities to engage with their public open space.

Specifically, this project provides a key access corridor for recreation and serves as the only feasible connection between the north and south aspects of the landscape and introduces an approachable and sustainably built trail to the city's infrastructure.

The Mount Dean Stone Corridor forms the only practical connection between the north and south halves of the larger Mount Dean Stone project. This corridor is a mosaic of seven private parcels which have been stitched together over the past several years by Five Valleys Land Trust, and present the only opportunity available for singletrack connections between the growing communities of Miller Creek and the greater Missoula Valley. This connection allows the existing Barmeyer and Sousa trailheads to serve a significant recreation resource as the larger Mount Dean Stone trails plan continues to develop. The Mount Dean Stone Corridor promises to set the tone for Missoula's next open space legacy.

Furthermore, this proposal includes the construction of a sustainably built and widely accessible singletrack trail. This is an essential component of the plan to the MTB Missoula membership and the larger trails constituency of Missoula. The existing trails inventory within the Missoula Valley tends to consist of singletrack that is very steep and intimidating, or more approachable forest or logging roads. While trails are at the heart of what make Missoula an incredible place to live, surprisingly few singletrack experiences are approachable by the youth, the elderly, and by inexperienced trail users.

The design criteria incorporated into the High, Wide, and Handsome trail are essential to the kinds of user experiences that are currently under developed and under served by existing trails in and around Missoula. These opportunities will only become more important as our community ages and youth cycling programs like the Missoula Mammoths and the City's own Zootown Derailleurs continue to increase in popularity at an explosive rate.

The Mount Dean Stone corridor project represents the best of what open space can mean to the Missoula community as we look forward to the realities of our growth. This effort meets the needs of underserved trail users and takes proactive steps to ensuring a bright future for Missoula's open space program.

Dear OSAC:

I write this letter with great excitement and enthusiasm about the opportunity that is before you. The Mount Dean Stone project has been in the works for many years. It started when a small group of smart and passionate conservationists poured over maps and decided the land connecting the front side of Mount Dean Stone to Upper Miller Creek should not be closed off to public access, which was proposed at that time. In an effort to protect important wildlife habitat, while also preserving the possibility for public access for recreation, the Nature Conservancy and Five Valleys Land Trust entered into a contract that would leave the door open for future community conservation of the land.

Five Valleys and the Nature Conservancy have been clear from the outset: to accomplish this ambitious goal, they would need the support and involvement of our community, state, federal and local government, numerous other conservation organizations, and private citizens. The City of Missoula, and this committee, now have the opportunity to continue as a central partner in the community conservation effort for Mount Dean Stone. City staff worked closely with Five Valleys Land Trust, The Nature Conservancy, and the many partners on the Mount Dean Stone Project committee to identify the key parcels needed to connect a recreation corridor from the Barmeyer and Sousa trailheads to the summit of Mount Dean Stone. This effort has taken countless hours of thoughtful planning, and the proposal before you today is the result of this hard work.

The Mount Dean Stone Corridor will open over five miles of new recreational trails across 350 acres of proposed conservation land. The proposed trail route will be accessible to a wide range of abilities and trail users, and will offer a recreational respite just on the edge of bustling Missoula. Open space provides myriad physical and mental health benefits, protects important views and vistas, and secures important wildlife movement corridors. This project will accomplish a host of goals of the City's new PROST Plan, the open space ordinance, and the 2018 open space bond. City acquisition of the 350 acres of land in the Mount Dean Stone Corridor will enhance the City's open space conservation network and add acreage to an important anchor area in Missoula's South Hills.

Five Valleys' request of \$925,000 is a significant discount from the overall costs of the project and the land. This project demonstrates the important value that land trust partners such as Five Valleys bring to each open space project. Now, City ownership of this land will allow the Conservation Lands Program to effectively manage the recreational corridors and habitat in the South Hills, and provide access to so many of Missoula's citizens.

I strongly encourage the committee vote in support of the proposal and of City acquisition of the Mount Dean Stone Corridor.
