A DESIGN REVIEW BOARD application must be made to the Zoning Officer by the property owner or a designated agent. The application and all required supporting documentation must be received and approved by the Zoning Officer at least thirty (30) days prior to the regular scheduled public hearing, which is held on the second Wednesday of each month in the City Council Chambers at 7:30 p.m., unless otherwise scheduled. The applicant or his agent must be present at the public hearing. Failure to appear at the public hearing is grounds for denial.

Zoning Officer Responsibility:

For **DESIGN REVIEW**, the Zoning Officer shall send certified first class mail notice of the proposed request and public hearing to property owners within one hundred fifty (150') feet of the subject property, post at least one notice of the proposed request and public hearing on each public street frontage abutting the subject property at least fifteen days prior to the public hearing, and publish two separate notices of the proposed request and public hearing in a newspaper of general circulation within Missoula, the first one to be at least 15 days before the public hearing date.

The office shall inspect all submitted material and submit a report to the Design Review Board and the applicant prior to the hearing. Once the Board has approved a motion, the Zoning Officer shall send written notification of the motion to the applicant. The Zoning Officer shall keep, on file, a record of the case.

Missoula Design Review Board Authority:

The Missoula Design Review Board consistent with all city council resolutions, motions and city council-approved review criteria, may deny or approve, in whole or in part, or may modify and set conditions for approval, or provide advice and counsel, for any request pursuant to this chapter (Ch. 20.90.020.A)

Dear Design Review Board Members,

The Albertsons company began offering a service in March 2020 called Drive Up & Go. The service allows customers to call in or email a shopping order that will be available for pickup. This service has become very popular with customers who have busy schedules, customers with small children, our elderly customers, and customers with mobility issues. An additional population using this service that was not anticipated back in March are those customers who are hesitant to shop in store during this COVID-19 time that everyone is experiencing.

This service has enabled our sales and service areas to grow their business and compete with other retailers who offer a similar service, including Kroger's, Walmart, and Rosauers, all of whom have this type of sign. It is estimated that 6% of the Albertsons customer base is using this service and it is anticipated that this percentage will continue to increase.

Albertsons has been installing Drive Up & Go signs at hundreds of their stores/banners across the United States. Currently there are 30 plus stores in the Northwest Division with the Drive Up & Go signs. The goal is to install the signs for all locations offering this service to help customers identify where they need to go to safely pick up their order. This helps the Albertsons employee who is delivering the order to the car and simplifies the pickup process for the customer.

The store located at 3800 S. Russell Street currently has an Albertsons sign, an Osco Pharmacy sign a Tully's Coffee sign and a First Interstate Bank sign, totaling 214 square feet. The building length is 262 lineal feet which will allow additional square footage.

We are asking for reconsideration on the number of wall signs that can be installed on a frontage wall. The Albertsons store located at 1003 E. Broadway currently has four signs and one being a Drive Up & Go sign. We hope you will find in our favor and thank you for your time and consideration.
