They've gone through the process of changing the lease, updating that, and now we have an extra 15 to 20 dollars a month that we're footing. So, kind of an unwelcome surprise but I understand that's how it will be from now on, but I just wanted to know there was an unintended consequence. I'm not sure if that was a concern that came up prior but yeah just wanted to pass that along, it's kind of a bummer but I guess it is how it is so thanks for your time.

<u>Mayor John Engen</u> Thank you Ms. Rehbein I will note for the record that Ms. Anderson is present.

<u>Alderperson Vasecka</u> Thanks I would like to separate 5.3 and 5.12 and may I speak to those briefly? <u>Mayor John Engen</u> You may.

Alderperson Vasecka I'm separating 5.3 to vote no on because I'm uncomfortable with the unknown future funding mechanisms for that. I'm also voting no on 5.12 because while I agree that these facilities are absolutely desperately needed, I'm uncomfortable with using the TIF funds for this. I believe it is inappropriate use of, of TIF dollars. I would prefer it to come out the general fund. So we had a really good discussion about these two items on Wednesday. So, I would encourage anybody who was interested in those conversations to go back and look at the discussion but that is my reasoning for voting no on those items tonight.

<u>Mayor John Engen</u> Further discussion? Seeing none. Anyone in the audience care to comment on any of the items on the consent agenda this evening? Yeah seeing no hands there. We will have a roll call vote on items 5.1 and 2, 5.4 through 11, and 5.13.

Marty Rehbein Hey this is on the consent agenda as amended. Anderson?

 - 7.1 Proclamation March for Meals

Mayor John Engen We do have one special presentation and it comes in the form of a proclamation. Whereas, The Meals on Wheels Program at Missoula Aging Services is a valuable resource to older adults in Missoula County and whereas more than 800 homebound elders and adults with disabilities received Meals on Wheels in the past year. With 130,881 meals served in Missoula County and whereas

volunteer drivers for Meals on Wheels are the backbone of this program. Through their dedication to bring not only hot nutritious meals to clients but also caring, concern, and attention to their welfare and whereas Missoula Aging Services counts on these volunteers and the support of the community to serve the growing numbers of elders who need this service in order to remain in their homes and whereas we wish to raise awareness and support for Meals on Wheels in Missoula and surrounding areas. Now, therefore, we the Missoula Board of County Commissioners and the Mayor of the City of Missoula do hereby proclaim the month of March 2021, as March for Meals Month, pardon me, in Missoula Montana and invite citizens to thank the caring volunteer drivers, recognize the value of this service to homebound elders and adults with disabilities, and encourage citizens to volunteer as Meals on Wheels drivers so that elders may remain in their homes. And this proclamation is signed by me as well, as David Strohmaier, Chair of the Missoula County Board of Commissioners, Commission Josh Slotnick, and commissioner Juanita Vero.

<u>Mayor John Engen</u> And with that, let me get to you Mr. Thompson. Apparently it requires some dexterity on my part that I don't have. There you are Dean; can you hear us? And can we hear you? Dean Thompson Yes, I can hear you.

Mayor John Engen We've got you. Thanks for your patience.

Dean Thompson Thank you Mayor Engen. Thank you fellow council members. I appreciate your letting me speak shortly tonight. Yes, the proclamation for Meals on Wheel, the March for Meals is, starts today. It's a, it's a month of awareness for the Meals on Wheels program, Missoula Aging Services. We promote the independence, dignity, and health of older adults and all those who care for them and so with that effort we, we work to make sure people who are homebound or have a disability or receive meals. It's been an especially trying year, as you all know with the COVID pandemic and our numbers in serving people went up 40 percent, and we serve about 325 people every day; we deliver meals to them. So, our goal is to raise 85,000 dollars throughout this month to help support that program annually and, and be able to have our volunteers touch base with the clients we serve. That's a, that's a, huge makes a huge difference in people's lives, having that volunteer check in every day and we couldn't do it without the 70 plus volunteers that we have every single day helping us through Missoula Aging Services. So, we appreciate the kickoff and, and the community support. We've been supported very generously throughout this past year by the community and we hope to continue to do that and reach our goal of 85,000. Mayor John Engen Thank you. We appreciate all you do. Many of you are familiar with the fact that my

parents were able to remain in their home longer than would have been possible without Meals on

Wheels, so very grateful for the program and the good work done there.

9.3 McNett Flats Major Subdivision - Dave DeGrandpre and Emily Gluckin- City of Missoula, Community Planning, Development & Innovation

This item has been returned to the Land Use and Planning Committee to be discussed on March 3, 2021 at 1:15 PM. The public hearing will be extended a week, and this item will appear on the Council agenda next week, March 8, 2021, under "Final Consideration."

Mayor John Engen We have a number of items for final consideration, pardon me, and these items were subject to public hearing. In most cases, we will have closed the public hearing this evening and taken final action on the items before the body. There are a couple of exceptions tonight. We're varying the theme a little bit. We will hold the public hearing on the McNett Flats Major Subdivision open because we have some new information and chairman Hess and staff would like to review that information and spend some time in committee and provides some opportunity for public comment as well on the new proposal. So McNett Flats will be, remain open, and we will not be taking comment on, I'm sorry, we will not be taking action on McNett Flats this evening and that public comment period will remain open. Mr. Hess, did you want to add anything for the good of the order?

<u>Alderperson Hess</u> Yeah Mayor, I might have to sneeze though. I apologize.

Mayor John Engen Fair enough.

Alderperson Hess Okay I think I'm good. So, there's, as you mentioned, a few moving parts and I wanted to, I wanted to give a little bit of an update. So, first of all, city staff released a memo on Saturday, I believe, addressing several of the issues that came up at the LU&P meeting last week and those, that's available for everyone to take a look at and I hope you've had the opportunity to review that. Second, I think the biggest issue that that is up for discussion on, on Wednesday is the, the question of the parkland dedication. I had worked with staff to compile comments from council members, or comments and questions from council members and members of the public about parkland and, and buffering and screening and transitions and, and just generally some, some issues about how this development would sit, this proposed development would, would sit next to existing established neighborhoods in 44 Ranch and in Flynn Ranch. So in response to those comments at the LU&P meeting, city staff proposed a hybrid in, in the subdivision regulations, basically a hybrid of parkland dedication and cash in lieu. And my understanding is that the developers were in receipt of that and, and made a new proposal about how they would like to handle parkland. And there's frankly a lot of, a lot of merit in both of those proposals but I just think it's really important that we have the opportunity for neighbors to review this, for council members to review it, for us to have a dialogue that's not on the fly tonight with staring down a

deadline to, to either vote yes or no on this. And so, the city requested an extension. This, this requires the developers consent. The developer consented to a one-week discussion, to a one-week extension which, which gives us time to have a discussion this week at LU&P and a continued opportunity to receive public comment and a final action next week. So I'll leave it at that I guess. I think, I think there will be materials attached to the agenda as well as on the city's public digest of all the city council emails, and I think we'll have a good discussion on Wednesday. Thanks.

Marty Rehbein Mayor John Engen. I'd like to raise a point of order. Dean Thompson with the Meals on Wheels program, I think, wanted to speak to the proclamation and his hand is up in the audience.

Mayor John Engen I will be happy to get back to Mr. Thompson; I appreciate that and I'm sorry I had no awareness that that was the case. Let me, let me dispense with McNett here quickly, however. Council members, I saw a couple of hands up with regard to McNett. I saw Ms. Becerra and Ms Anderson. Nope? Okay. All right, anyone in the audience care to comment on the McNett Flats Subdivision, keeping in mind that the public hearing will remain open and new information will be presented on Wednesday before final consideration next Monday evening. All right seeing none, we will consider that item in committee on Wednesday and the public hearing will remain open.

<u>Mayor John Engen</u> We will be back in order in with items of final consideration. First of which will be a motion to annex a parcel. And Mr. Hess.

Alderperson Hess Thank you mayor. I move that we adopt a resolution to annex and incorporate within the boundaries of the City of Missoula, one certain parcel of land described as parcel 1-A of certificate of survey 6689 located in section 7, township 13 north, range 19 west, principal meridian Montana and shown on exhibit A and zone the property C2-2 community commercial based on the findings of fact in the staff report subject to condition, the recommended conditions of annexation approval, and may I speak to the motion?

Mayor John Engen You may.

Alderperson Hess This is a pretty straightforward annexation. We've, we've had a public hearing and didn't uncover anything untoward here. This is a proposal to add some loft style residential units on Mary Jane Boulevard and Broadway that will serve a particular housing need and I think this is, you know it's important to highlight that this is within the Sxwtpqyen Area Master Plan. It's also within the build grant area where we're actively preparing to build infrastructure next year, and it's within our annexation area B, which is our priority for, for annexing. So, I think it's fairly straightforward and I think there's you know there's no red flags for me so I'm happy to support this.

<u>Mayor John Engen</u> Thank you Mr. Hess. Our public hearing is closed. Is there discussion on the motion? Seeing none, we will have a roll call vote.

<u>Mayor John Engen</u> Our third and final item for final consideration this evening is a resolution and ordinance establishing the Sxwtpqyen Area Transportation Special Impact Fee. And Ms. Becerra, do you have a motion for us?

Alderperson Becerra Yes. Thank you Mayor. There are two motions associated with this item. The first one is, I recommend that city council adopt an ordinance creating chapter 15.70 Missoula Municipal Code entitled Sxwtpqyen Area Transportation Special Impact Fee to establish the impact fees for new development in accordance with the results of an official impact fee study commissioned by the City of Missoula for the Mullan Build Project. And the second motion would be a recommendation to adopt a resolution generally establishing the Sxwtpqyen Area Transportation Special Impact Fees as proposed by the Missouri Public Works and Mobility Department effective March 31, 2021. And may I speak to the motions please?

Mayor John Engen Ms. Becerra.

Alderperson Becerra I am fully supportive of establishing impact fees in this area. I think that would allow us to provide and extend infrastructure to new development and plan, in a, plan in a cohesive way. I think it's an equitable way to address the cost of extending this infrastructure in this area and I think the fee structure that is being proposed with this, with this ordinance encourages and aligns well with the Sxwtpqyen Plan that we recently adopted. So, for all of those reasons, I will be supporting this, the impact fees.

<u>Mayor John Engen</u> Thank you Ms. Becerra. We have had a public hearing now we'll have discussion on the motion. Mr. Hess.

Alderperson Hess Thanks. I want to echo Ms. Becerra's comments. I think that the Sxwtpqyen Area Master Plan and the build grant both provide a visionary framework for this area and the special impact fees help fund that in a way that's equitable, in a way where growth pays for itself, in a way where we are able to plan and develop infrastructure on a large scale and achieve some economies of scale and achieve some, some orderly and predictable development of the area. So, it's all good, all good moving parts here and I thank public works for putting together this this proposal and I'm happy to support it.

Mayor John Engen Thank you Mr. Hess. Further discussion? Seeing none, I will express my appreciation to Mr. Keene, Mr. Bickle, and staff for putting this creative solution together. That gets more done more quickly more equitably than would have happened in the alternative. This required a little bit of creativity in light of a build grant application that was funded about half of what was requested, and it

would have been easy enough to, to abandon large portions of the project and hope for the best and staff did not, did not pursue that option they pursued the better one. And you all have an opportunity to support that this evening and hope that you do. Seeing no one in the audience interested in commenting, we will have a roll call vote. We have no additional items for final consideration this evening.

Alderperson von Lossberg I'll pass, thanks.

Mayor John Engen Ms. Jones? Ms. Sherrill.

Alderperson Sherrill I just wanted to make a quick comment on the proclamation that you made. I'm, I just want to express, I don't know if he's still in the meeting or not, to Dean and to Missoula Aging Services, as well as the Meals on Wheels program through them, how important this has been for our community for through this pandemic. I was going to raise my hand and actually ask how many, what their increase had been over the past year, but he said 40 percent more seniors, that they are serving. I mean that is, that is a huge increase. I don't actually know how they did it. I mean if you think about just making the meals, delivering the meals, all of the logistics that go into something like that. I, I'm, I'm just amazed that they responded to that call and I'm thankful that we have them I used to deliver Meals on Wheels years ago in Missoula and found it really rewarding and have appreciated the program ever since. So, thank you Dean if you're still in the meeting and please express my thanks to Missoula Aging Services.

<u>Mayor John Engen</u> And we'll continue council comments with Mr. Nugent, just kidding. Ms. Merritt. <u>Alderperson Merritt</u> I pass.

Mayor John Engen Mr. Contos.

Alderperson Contos Pass. Thank you.

Mayor John Engen Ms. Harp.

Alderperson Harp I just want to take a moment to congratulate the U-19 girls red hockey team. They have created quite a legacy in this community. This is their sixth-year winning state championship, and this year was a very unique particular year. We've had the best team in the state for, well at least five years and due to COVID and the restrictions that we had in terms of play, we actually had to split the squad into two. So we actually the highest first and second highest ranked teams and needless to say

one team ended up with a heartbreak but the other certainly made us proud and continues the legacy. So, congratulations to all the girls seventh grade through seniors you did a fantastic job.

Mayor John Engen Mr. Hess.

Alderperson Hess Thanks. I wanted to acknowledge Kara Gruwell's comments about unanticipated costs being passed on to renters, when, with the combined utility billing. When, when we first talked about the combined utility billing, this was something that I was really keenly interested in and we talked about it at length in, in that process and my understanding from our, our staff comments were that staff didn't believe that that was a risk and that sewer bills remain the, the responsibility of the property owners. So, I'm, I'm concerned that this is, that this is happening and that we have a, an on the ground case of this happening. I think that's contrary to the intent of what, of what we set out to do. We set out to, to make those, those changes to, to save to save time and effort at the city, to save time and effort in in bill paying with, with, with the public, and we certainly intended to preserve anything that, that would, that could impact housing affordability. I guess I don't have an answer other than, than that it's, it's concerning that that is happening, and I hope that we can have some discussions about why that is, in fact, happening and if there's, if there's any if there's any remedy. Thanks.

Mayor John Engen Thank you Mr. Hess. Ms. Becerra.

Alderperson Becerra I'll pass, thank you.

<u>Alderperson Anderson</u> Thank you so much Mr. Mayor. I'll make my comments brief since we are looking like having a short meeting this evening. I do want to update the public about some changes in regard to how people can get information in regard to the COVID vaccine, the rollout, and when you or your loved one may be eligible. There's a couple different ways in which folks can do that. One of them is to call the health department hotline number which is 528-INFO, which is 528-4636. That line...

Mayor John Engen That would be 258, let's make that clear for the record.

<u>Alderperson Anderson</u> Boy, oh boy. Okay, it's been a long case of the Mondays. Thank you. It takes a village to keep me....

Mayor John Engen It does.

Alderperson Anderson To keep me on task..... So okay, let's try this one more time. Yes, 258-INFO or 258-4636. The good news is, when you get the number right, it's manned by a live person, 8:00 a.m. - 5:00 p.m., seven days a week. What they've recently added which I'm really excited about is that if you

are unable to call that number during working hours, 8:00 a.m. - 5:00 p.m., but yet you have questions, you can now call anytime and there'll be an updated recorded message available to listen to that will give you updates on what tier we're at in terms of the vaccine rollout, the number of vaccine clinics available, and any additional information. So now if you're not able to call during the day and talk to one of the fabulous health department staff, you still will have access to information. I applaud the health department for trying to continue to find ways to make sure that everyone in our community has access to this information. I know there's some frustration about the fact that vaccines seem to be rolling out slowly and it is just literally a lack of files, not infrastructure or people working around the clock to try to make sure that as soon as we get those shots we're able to give them to the folks in our community. And so, you can call that number or anytime you can check the website which is COVID19.missoula.co and that has the most up-to-date information. So, let folks in your networks know. I realize not everyone has access to the internet and some people work shift hours, they may not be able to call during the day. So I really thank the health department for thinking about ways to make sure that everyone in our community knows about how to get a vaccine and continue to get that vaccine out as quickly, as quickly and equitably as possible. Thank you so much.

<u>Mayor John Engen</u> Thank you Ms. Anderson. I will note that our vaccine team, through incident command, is working a lot of that communications magic as well and deserves kudos too. Ms. Vasecka, you're wrapping us up.
