Action Required:

Conduct a public hearing and consider an ordinance amending Title 1, Chapter 1.16 entitled "Election Wards."

Recommended Motion(s):

- City Council February 22, 2021: *First reading and preliminary adoption*: Set a public hearing for March 8, 2021, and preliminarily adopt an ordinance amending Title 1, Chapter 1.16 entitled "Election Wards" revising and updating ward boundaries based on new population statistics.
- City Council Final Consideration March 22, 2021: **Second and final reading**: Adopt/deny an ordinance amending Title 1, Chapter 1.16 entitled "Election Wards" revising and updating ward boundaries based on new population statistics.

Project Summary:

Currently, adjustments to Ward boundaries are necessary in order to maintain practical equality of population inside each ward. Ward 2, Ward 3, Ward 4, and Ward 5 are out of alignment; therefore, a public hearing is needed to consider an ordinance to realign the Ward boundaries.

Background and Alternatives Explored:

Each ward shall be established and maintained by the City Council to be generally regular in shape and as equal in population as practically possible. Every two years City Council considers changes to Ward boundaries.

The updated ward populations have been an aggregate of the 2010 decennial census population data and population derived from new residential construction based on building permits over the years and presented in two year increments aligning with ward redistrict considerations.

The total estimated city population as of December 31, 2020 is 78,376. The average estimated population per ward is 13,063. At +/- 3 percent, ward population should range between 12,671 and 13,455 people. However, Wards 2,3,4, and 5 do not meet this criterion. Wards 2 and 5 deviate on the high side and Wards 3 and 4 deviate on the low side. See the following tables for estimated populations.

At this time, staff has determined that ward populations are misaligned and that adjustment of ward boundaries based on population equality is necessary. Staff has prepared a preferred ward boundary scenario for COW to consider.

In order to accommodate the opening of filing for this year's municipal elections, the latest possible date for Council action is March 22, 2021, so the ordinance can go into effect by April 22, 2021.
