3.1 Referral – Professional Services Agreement with WGM Group for the Russell Commuter Trail Crossing

Mark Todorovich Construction Project Coordinator Surface Engineering Public Works & Mobility presenting,

The South Russell Commuter trail crossing is North of the YMCA and across from Opportunity Resources. The crossing will include bulb-outs, flashing indicators, a center median refuge island, and lighting. A few years ago, a pedestrian was hit crossing the road in this area. This crossing would allow pedestrians to access Opportunity Resources better as well as the new commuter trail. The City and County will split the funding costs, which are estimated at \$146,500 that includes design and construction. WGM was selected because of previous work they did on the commuter trail in that area.

Mr. Contos explained that he drives this road frequently and questioned the need for a crossing. Mr. Slovarp, City Engineer for Transportation, replied that a pedestrian was hit by a vehicle in this area and the businesses in the area have asked the City to look into a way to help commuters access the businesses. The original design didn't tie in the bike and pedestrian facilities across Russell street. They need a safe way to get to the trail.

Ms. Jones added that Council has had several conversations about Russell and people crossing safer. Many people, especially kids from the neighborhood behind Opportunity Resources, cross Russell going to Russell School, the YMCA, or Playfair Park. On the other side, people who ride the bus cross Russell to go to Opportunity Resources. It's a street that does not have good access East and West.

Ms. Harp mentioned that driving Russell street is different than trying to cross such a busy road. She wanted to know what other options were looked at and why this contract for \$28,315 was the best option. Mr. Slovarp said these improvements are the least expensive option they have come across. Ms. Becerra added that we do need to focus on connecting all these trail systems to help reach our multi-modal transportation goals.
